William Alington, 1st Baron Alington of Killard was baptised on 14 March 1610/11 in Horseheath, Cambridgeshire, England. He was the son of Sir Giles Alington and Lady Dorothy Cecil. He married Elizabeth Tollemache, daughter of Sir Lionel Tollemache, 2nd Bt. and Hon. Elizabeth Stanhope, before 1 October 1631. He died circa October 1648. He was buried on 25 October 1648 in Horseheath, Cambridgeshire. William Alington was created 1st Baron Alington of Killard, Co. Cork [IRELAND] on 28 July 1642. He lived in Great Wymondley, Hertfordshire, England and in Horseheath, Cambridgeshire.

Sir Giles **Alington** was born circa 1572. He was the son of unknown **Alington** and Margaret. He married, firstly, Lady Dorothy **Cecil**, daughter of Sir Thomas **Cecil**, 1st Earl of Exeter and Dorothy **Neville**, before 1601. He married, secondly, Dorothy **Dalton**, daughter of Michael **Dalton** and Mary **Elrington**, on 2 December 1630 in West Wratting, Cambridgeshire, England. He died circa December 1638. He was buried on 23 December 1638 in Horseheath, Cambridgeshire, England. In 1631 he was censured and fined £32,000 in the Star Chamber for marrying his neice by the half-blood, and did penance. On 7 January 1633/34 the offenders had "pardon for incest, provided they shall not hereafter cohabit." He lived in Horseheath, Cambridgeshire.

## The Bromleys, Lords Montfort of Horseheath

Baron Montfort of Horseheath was a title in the Peerage of Ireland created on 20 August 1741 for Henry Bromley. (The Peerage of Ireland is the term used for those peers created by British monarchs in their capacity as King of Ireland. Before 1801, Irish Peers had the right to sit in the Irish House of Lords, but after the Union in 1801, Irish peers only elected representative peers to the House of Lords. This practice ended with the creation of the Irish Free State in 1922.)

On the death of the 3rd Baron in 1851, the barony became extinct.

#### BROMLEY, LORD MONTFORT

THOMAS BROMLEY, Baron Montfort of Horseheath; high steward of the borough of Cambridge, and doctor of laws. This nobleman was born February 1733, and succeeded to the title upon the death of his father 1 January 1755. Lord Montfort married 1 March 1772 Mary Anne, sister of sir Patrick Blake of Langham in the county of Suffolk; by which lady he has issue Henry, born 14 May 1773.

The family of Bromley has been traced back to the reign of king John. William Bromley, in the reign of king Edward the third, had issue,

- 1. John.
- Richard, father of John, who served in the wars of King Henry the fifth for the crown of France, and distinguished himself by his gallant behaviour in recovering the standard of the Duchy of Guienne, which had been lost, in the battle of Corbie in the year 1417.

- Thomas, who in the beginning of the reign of queen Elizabeth was elected recorder of the city of London, which office he exchanged 14 March 1569 for that of solicitor general to the queen. He was farther promoted 25 April 1579 to be Lord High Chancellor of England, and died 12 April 1587.

Mercy, sixth in descent from lord chancellor Bromley, married John Bromley of Horseheath esquire, representative for the county of Cambridge; by whom file had issue Henry, who was created by king George the second baron Montfort of Horseheath, and married Frances, sister and heiress of sir Francis Wyndham of Trent in the county of Somerset baronet; by which lady, who died 11 February 1733, he had issue,

- 1. Frances, married to Charles Sloane, Lord Cadogan. She died 20 May 1768.
- 2. Thomas, present and second Lord Montfort.

SUMMARY: The document below likely dates from late 1562 or early 1563, and lists 103 knights' fees belonging to the 16th Earl of Oxford at his death. A knight's fee was a military tenure by which land was held from a lord in return for military service. In the feudal period, the military obligation was real, but by the 16th Earl's time, tenants were rarely called upon to come armed into the field to fight for their lord. The total value of the fees listed for Essex is £3 19s 2d, for Suffolk 17s 8d, for Cambridge, 10s 8d, for Hertford 4s, for Norfolk nothing, and for Buckingham 10s 4d, for a total of £6 1s 10d. As indicated in the document, nothing at all was paid for 49 of the 103 fees.

Valuation of the fees, which lately belonged to John Vere, Earl of Oxenford, deceased, appertaining to divers honors in the county of Cambridge, as follows:

Horseheath Giles Alington holds a half fee in Horseheath called Limberies.
